FINDS that the **Decision** issued under separate cover should be incorporated in this Judgment Entry by reference as if having been fully restated.

FINDS that the Ohio Civil Rights Commission's 2/23/2017 Cease and Desist Order should be affirmed.

FINDS, however, that all deadlines in the Commission's **Cease and Desist Order** should be modified so that the deadlines commence on the file-stamped date of the Judgment Entry incorporating this Decision, instead of the date of the Commission's Final Order.

FINDS that the Clerk of Courts should close this case file and remove it from the pending case docket.

FINDS that Court costs should be assessed as follows:

- ♦ Petitioner Wilkshire - 100%
- ♦ Commission - 0%

It is therefore

ORDERED that the **Decision** issued under separate cover is incorporated in this Judgment Entry by reference as if having been fully restated.

ORDERED that the Ohio Civil Rights Commission's 2/23/2017 **Cease and Desist Order** is affirmed.

ORDERED, however, that all deadlines in the Commission's **Cease and Desist Order** are modified so that the deadlines commence on the file-stamped date of the Judgment Entry adopting this Decision, instead of the date of the Commission's Final Order.


ORDERED that the Clerk of Courts shall close this case file and remove it from the pending case docket.
