We the undersigned organizations write to express our appreciation and gratitude to you for hearing our concerns, valuing our participation, and ultimately removing the misguided amendments to Revised Code § 5123.62 from H.B. 64 (the state biennium budget bill for fiscal years 2016-2017).

The controversial amendments to the "DD Bill of Rights" that were discussed during the budget process would have made significant changes to essential rights of Ohioans with intellectual and developmental disabilities without adequate opportunity for those Ohioans to fully participate in the legislative process. As we approach the 25th anniversary of the Americans with Disabilities Act (ADA), it is only fitting that during the budget process you heard the call of thousands of people with disabilities who asked you to recognize a simple phrase that conveys a powerful message - "nothing about us without us."

Indeed, you have honored the spirit of and value for the full participation and inclusion of individuals with intellectual and developmental disabilities by ensuring that the DD Bill of Rights will remain intact. Should changes be sought, there must be ample opportunity for direct and meaningful input by those most affected: people with intellectual and developmental disabilities.
