# Ohio Department of Education and Disability Rights Ohio Receive Preliminary Approval for Reaching Settlement in Class-action Lawsuit

The agreement will outline a plan to improve the integration and academic achievement of Ohio students with disabilities

Columbus Ohio – Nov. 18, 2019 –The Honorable Judge Michael H. Watson of the United States District Court for the Southern District of Ohio has granted preliminary approval to a comprehensive settlement agreement in the class action *Doe v. State of Ohio*, case number 2:91-cv-00464. Disability Rights Ohio (DRO), the Judge Bazelon Center for Mental Health Law, and the law firm of Steptoe & Johnson worked with the Ohio Department of Education to reach a settlement that will improve the State's support for special education throughout Ohio, as well as support measurable improvements in student performance and inclusion for children with disabilities in 11 of Ohio's school districts. The settlement will be in effect for five years.

The settlement requires extra support to improve experiences and outcomes for students with disabilities in 11 school districts – Akron, Canton, Cincinnati, Cleveland, Columbus, Dayton, Lima, East Cleveland, Toledo, Youngstown and Zanesville –which currently have lower academic outcomes for students with disabilities. The plan will build upon *Each Child, Our Future*, Ohio's strategic plan for education and the Ohio Department of Education's developing plan aimed at improving learning experiences and outcomes for students with disabilities. The plan will promote effective teaching and administrative strategies for improving literacy, positive behavioral interventions and supports, and meeting the individualized learning needs of students. The settlement will ensure more options are available for students as they transition from high school to employment, further education, and independent living.

"This settlement could not have been reached without the collaborative effort of our partners and the Ohio Department of Education. Together we were committed to reaching a comprehensive settlement that will improve outcomes for students with disabilities in real and concrete ways," says Kerstin Sjoberg, director of advocacy and assistant executive director at DRO. "We are excited to join forces with ODE to support a statewide plan that will enhance academic achievement, promote inclusion, and improve the supports students with disabilities receive in school."

"Equity is a core principle of Ohio's strategic plan for education," says Paolo DeMaria, state superintendent of public instruction. "The settlement affirms the objective of meeting the needs of all children, no matter the challenges they face, with the goal of ensuring they are prepared and empowered for a fulfilling post-high school path."

The class members now have the opportunity to submit comments on the Settlement Agreement before the Judge holds a fairness hearing.
